MEMORANDUM OF UNDERSTANDING

WISCONSIN TECHNICAL COLLEGE SYSTEM
AND
LAKELAND UNIVERSITY

A.A.S. Accounting to B.A. Accounting

The purpose of this document is to establish a cooperative relationship between Lakeland University (LU) and the sixteen (16) schools in the Wisconsin Technical College System (WTCS) to provide a Baccalaureate degree opportunity to students who are completing an Associate in Applied Science in Accounting and wishing to enroll in LU's Bachelor of Arts in Accounting program. This partnership will assist in better serving the needs of associate degree students with personalized admissions and academic advising services throughout the student's lifecycle.

WHEREAS, in consideration of this partnership, the WTCS schools will allow LU to provide students with information about LU's B.A. Accounting program through mutually agreed upon channels of communication; and,

THEREFORE, LU will provide the following to students: a.) guaranteed admission to the bachelor's program following completion of the associate degree, with students beginning as juniors; b.) 20% discount for the remainder of the student's baccalaureate studies at LU; c.) waiver of admission application fee, and d.) support from LU advisors during and after the transition from the associate to bachelor's program.

This partnership is effective January 4th, 2024, and will continue until either party requests the dissolution of said partnership in writing and signed by the authorized representative.
