**1. Rationale of Articulation Agreement**

This program-to-program articulation agreement between the Wisconsin Technical College System and the University of Wisconsin-Whitewater (UWW) (effective Fall 2020) allows students to be awarded 38 credits toward a B.S.E. degree in Early Childhood Education (Certification in EARLY CHILDHOOD REGULAR EDUCATION and EARLY CHILDHOOD SPECIAL EDUCATION) if they meet the following criteria. The students:

- 1.1. started an A.A.S. degree program in Early Childhood Education (ECE) within the WTCS beginning in or after August of 2006 but prior to August 2019 (following the revised WTCS statewide ECE core curriculum)
- 1.2. have successfully completed the A.A.S. degree
- 1.3. have applied to and are successfully admitted into UWW.
